

ORDINANCE NO.2004-33

AN ORDINANCE OF THE CITY OF MABANK, TEXAS TO REPEAL ARTICLE 341.001a OF THE MABANK CITY CODE AND TO AMEND ARTICLE 341.001b OF THE MABANK CITY CODE PERTAINING TO THE DESIGNATION OF ONE WAY STREETS AND THE TEMPORARY CLOSING OF EAST MARKET STREET; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

SECTION 1. Article 341.001a of the Mabank City Code (Ordinance No. 91890) is hereby repealed to allow two-way traffic flow on North Coleman Street, South Coleman Street and East Market Street twenty four (24) hours per day. All existing signage regarding one-way traffic flow during certain hours of the day shall be removed.

SECTION 2. Article 341.001b of the Mabank City Code is hereby amended to read as follows:

The City Council of the City of Mabank, Texas grants permission to the Mabank Independent School District to close East Market Street at the MISD school facilities located at 310 East Market Street for Little League basketball and other special events or occasions when the closure is deemed necessary for public safety, following approval by the City Administrator and the Chief of Police. Advance notice of all closures shall be provided to the City. The Mabank Independent School District shall use proper barricades for any street closing.


SECTION 3. Severability.

The repeal provided for in Section 1 of this Ordinance shall not affect any other articles in the City of Mabank Code of Ordinances.


SECTION 4. Effective Date.

ARTICLE 341.001a ONE WAY STREETS

SECTION I. DEFINITIONS

One Way Street describes a street or portion thereof upon which all vehicular traffic is required to flow in the same direction as designated by signs properly placed.

Two Way Traffic describes the normal flow of traffic upon a divided street upon which traffic may legally proceed in two directions.

SECTION II. DESIGNATED STREETS

The following streets are hereby designated and restricted for one way traffic, in the direction and for the duration hereafter specified;

<u>Name Street or Portion Thereof</u>	<u>Effective hours</u>	<u>Direction of Traffic</u>
North Coleman Street from its intersection With Kempner Street to its intersection With East Market Street	7:00 a.m. until 9:00 a.m. 2:00 p.m. until 4:00 p.m.	South South
South Coleman Street from its intersection With U.S. Highway 175 to its intersection With East Market Street	7:00 a.m. until 9:00 a.m. 2:00 p.m. until 4:00 p.m.	North North
East Market Street from its intersection with Coleman Street intersection With South Kemp Street	7:00 a.m. until 9:00 a.m. 2:00 p.m. until 4:00 p.m.	East East

SECTION III. SIGNS

The said streets shall be properly marked with legible signs designating the lawful direction of traffic flow and the period in which said one-way flow of traffic shall be in effect.

SECTION IV. TWO WAY TRAFFIC

During the periods not designated as "one-way" the directional flow of traffic shall revert to two-way traffic.

SECTION V. FINE

Whoever shall be found guilty of violating this ordinance shall be guilty of a Class C Misdemeanor.

ARTICLE 341.001b TEMPORARY CLOSING OF EAST MARKET STREET

SECTION 1. PERMISSION

The City Council of the City of Mabank, Texas grants permission to the Mabank Independent School District to close East Market Street at the Elementary and Junior High Schools during school hours, 7:00 a.m. to 4:00 p.m. Monday through Friday, Five (5) days a week, using proper barricades for street closing.
